



## Registered Professional Forester – Northern/Central California

### General position summary:

Approximately 70% of projects are located within a 1.5-hour travel time from our base location of Auburn, CA. The remaining 30% are located within northern and Central California. The work is split 50% in the field and 50% in the office.
